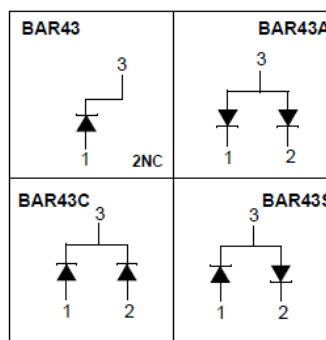

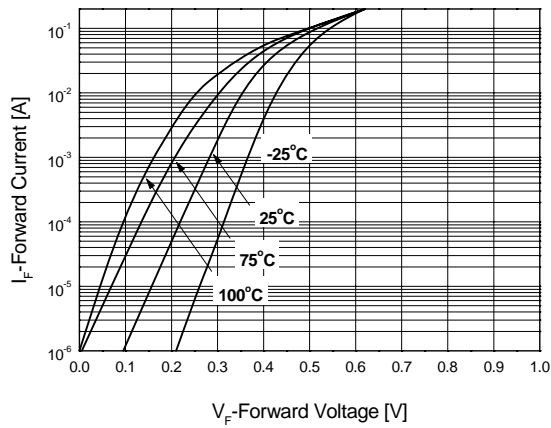

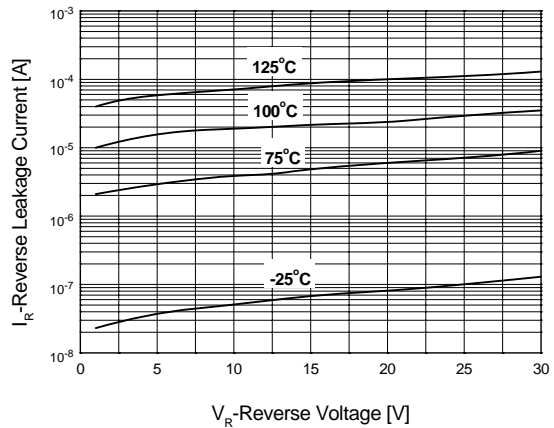

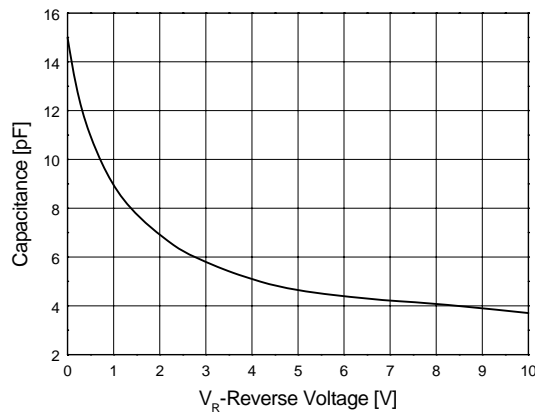
**Figure 1. Forward Voltage vs Temperature**



**Figure 2. Reverse Leakage Current vs Temperature**








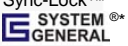
**Figure 3. Capacitance vs Reverse Bias Voltage**
